## (Neb.)-USDA Census Of Agriculture And Minority Farm Register Information

### 2012 Census of Agriculture

(NORTHWEST NEB.)-USDA's National Agricultural Statistics Service (NASS) will be focused on encouraging all farmers and ranchers to respond to the 2012 Census of Agriculture. Ag Census forms were mailed in December. NASS is an important census-taking agency within the US Department of Agriculture.

The Census of Agriculture is conducted only once every five years to accurately collect demographic information about farmers, ranchers and their operations in our country's rural and agricultural communities. USDA and many other agencies, institutions and organizations use the results of the Census for education, research, planning and policy-making decisions within government, as well as business, industry and academia. The use of this valuable information impacts everyone across our nation.

While the Census is particularly vital for rural America, it is important to remember that well-informed policy decisions have a positive impact for everyone. Even for families in our largest cities, a strong rural America means an abundant food supply, cleaner water, extraordinary outdoor recreation and more. That is why it could not be more important to make sure that all of our nation's farmers and farmland are accurately accounted for.

NASS mails the Census of Agriculture in mid December with a return deadline of February 4, 2013. If you receive an Ag Census form, please complete and return it by the deadline.

### USDA Minority Farm Register

The USDA Minority Farm Register is a tool to promote equal access to USDA farm programs and services for minority farmland owners, farmers, ranchers, tenants, and other individuals with an agricultural interest. Participants may receive information or be personally contacted through USDA outreach efforts. USDA programs include direct and guaranteed farm ownership and operating loans, marketing loans, as well as conservation, housing & rural business, and risk management.

Participation in the Register is voluntary. All minority persons involved in farming or ranching are encouraged to participate. The information you provide may be shared through the USDA Office of Outreach with other USDA-approved outreach partners such as community-based organizations, educational institutions, and other government agencies. If you are involved with farming or ranching and wish to be included in the Minority Farm Register, you are invited to complete the Minority Farm Register form, AD-2035, and mail it to the Farm Service

Agency. Only your name, address, signature, and the date you signed the form are required to participate.
